## 1. Vehicle & Usage Eligibility

Vehicle must be used only for personal / retail purposes

(Not allowed: commercial use, demo cars, display cars, racing, rallying, driving schools, competitions, transport of goods or hire use).

Vehicle must remain in manufacturer-specified original condition.

No modifications permitted — including colour change, welding, cutting, or chassis alteration.

Vehicle must be in technically sound condition and free from accident history, except minor cosmetic damage.

Odometer tampering voids the policy from inception.

## 2. Insurance & Legal Compliance

Vehicle must have continuous comprehensive motor insurance for the entire certificate period.

Vehicle must be free from legal disputes, fines, penalties, RTO violations, encumbrances, and unpaid dues.

All insurance premiums must be fully paid and up to date.

## 3. Financial & Loan Obligations

If vehicle is financed, all loan dues must be fully cleared before claim.

Original NOC from the financier is mandatory for claim processing.

Beneficiary must not be in default under any vehicle-related loan.

#### 4. Condition at Claim Time

Vehicle must comply with the Wear & Tear Guidelines at claim time.

Must be in proper mechanical, electrical, and electronic working condition.

Must not show excessive corrosion, abnormal wear, or major damage.

All original keys / key fobs must be available.

#### 5. Sale & Claim Restrictions

Vehicle cannot be sold without the company's prior written approval.

Vehicle cannot be sold below the highest bid received during the resale process.

Claim intimation must be given within the "Intimation Window" (up to 90 days before certificate expiry).

Vehicle must be made available for inspection.

If vehicle fails inspection, insured gets 15 days to repair and re-present.

Failure to comply gives the insurer the right to reject the claim.
